



## AFGHANISTAN RECONSTRUCTION TRUST FUND (ARTF)

Administrator's Report on Financial Status

As of October 22, 2021, (end of 10<sup>th</sup> month of FY1400)

**1. Donor contributions for FY1400:** Total donor indicated<sup>1</sup> and actual (paid-in) contributions for FY1400 amount to US\$429.99 million, of which US\$264.58 million (62%) are without preference and US\$165.41 million (38%) are preferenced. Table 1 reflects total donor indicated contributions and paid-in amount.

## 2. Consolidated ARTF Sources and Uses of Funds for FY1400:

Table 2 presents sources and uses of funds for FY1400 on a consolidated basis as of October 22, 2021. The sources of funds are net donor contributions, investment income less administration fees and the cash balance carried forward from FY1399. As of October 22, 2021, the cash balance stood at US\$1,547.66 million comprising: (a) US\$0 balance in the Recurrent Cost IPF Child Trust Fund; (b) combined undisbursed balance of the ARTF active investment portfolio of US\$876.65 million; (c) US\$2.23 million combined undisbursed balance of the ASIST Window; (d) US\$0 million reserved for the Monitoring and Supervisory Agents; (e) US\$0 balance in the Recurrent Cost Window; and (f) US\$19.11 million reserved for the ACRMAP window, leaving a net unallocated cash balance of US\$649.67 million.
