**Administrator's Report on Financial Status**  
**as of April 20, 2007 (end of Hamal – 1<sup>st</sup> month of SY1386)**

**1. Donor contributions for SY1386**

Total donor pledges for SY1386 amount to US\$483 million comprising US\$331 million (69%) without preference and US\$152 million (31%) with preferences. Table 1 reflects, as of April 20, 2007, the paid-in donor contributions (amounting to US\$43 million). The German contribution of EUR 20 million, pledged for SY1385, was received on March 23, 2007 (i.e. in SY1386) and is thus recorded as a SY1386 pledge/payment.

**2. Projected Consolidated ARTF Sources and Uses of Funds for SY1386**

Table 2 presents projected sources and uses of funds for SY1386 on a consolidated basis. The sources of funds are net donor contributions (contributions less IDA fees plus investment income). Cash balance at the end of SY1385 is carried over to SY1386.

Uses of funds comprise: (a) funding of the recurrent budget, set at US\$279.5 million; (b) disbursements under the ARTF investment window, estimated at US\$175 million for the year; and (c) fees for the Monitoring Agent of about US\$4.75 million<sup>1</sup>.

<sup>1</sup> This includes US\$ 1 million for the special Internal Control Framework job, US\$ 2 million for services rendered till September 2007, and US\$ 1.5 million for services from October 2007 till the end of SY1386.

## Financials as of April 20, 2007

As of April 20, 2007 (end of Solar Year 1385) the cash balance of ARTF stood at US\$326.28 million comprising: (a) a US\$125.03 million cash balance in the recurrent cost window; (b) combined undisbursed balance of the ARTF active investment portfolio of US\$91.38 million; and (c) US\$7.32 million reserved for the Monitoring Agent, leaving an unallocated cash balance of US\$102.55 million. Of this unallocated balance, the ARTF Management Committee has already approved allocation of US\$10 million for the Management Capacity Project which will be affected soon after the signing of the legal agreement for the new program.

The Pool is subdivided into sub-portfolios to which allocations are made based on fund specific investment horizons and risk tolerances and other eligibility requirements set by the Bank. Generally, the Pool is invested in liquid financial instruments such as money market instruments, government and agency obligations, mortgage-backed securities, and other high-grade bonds. Based on the Bank's investment strategy for trust funds, each sub-portfolio is invested in a combination of these asset types consistent with the applicable risk tolerance for the sub-portfolio. Share in Pooled Cash and Investments represents the Trust Fund's pro-rata share of the Pool's fair value at the end of the reporting period. The fair value is based on market quotations, where available. If quoted market prices are not available, fair values are based on quoted market prices of comparable instruments. The corresponding proportionate interest income and investment gains/losses, accrue to the Trust Fund in the period in which they occur.

### 3. Recurrent Cost Financing requirements

The annual Recurrent Cost financing requirement is the amount of transfer required for the year from the ARTF parent Trust Fund account to the Recurrent Cost Trust Fund account.

The amount must be sufficient to finance the disbursements of the Recurrent Cost Trust Fund to the Government (which was agreed at US\$270 million for SY1386). Additionally, the transfer must be sufficient to also restore the balance of the Recurrent Cost Trust Fund to the agreed buffer of US\$70 million. Therefore, an amount of US\$ 279.5 million is to be transferred to the recurrent cost financing trust fund during SY1386 as explained in the table below.

The estimate of funding allocations to the recurrent cost window for a specific quarter is determined by comparing the balance of the Recurrent Cost window trust fund<sup>2</sup> to the estimated disbursement requirement for the quarter in question, plus a reserve equal to the next quarter disbursement requirements. For SY1386, the forecast for the full year appears below. The quarter-by-quarter distribution depends on the planned pattern of presentation of expenses, which the Government will determine.

#### 4. Investment Window

As of April 20, 2007, the ARTF investment window comprised of 10 active investment projects, with combined commitments of US\$418.55 million, of which US\$327.73<sup>3</sup> million has been disbursed (78%). Disbursements for SY1386 are projected at US\$ 175 million.
